HEARING DATE FOR DISSOLUTION  
OF SNOHOMISH HEALTH DISTRICT

THIS MATTER coming on regularly for hearing on the Petition for Dissolution of the SNOHOMISH HEALTH DISTRICT, and the Petitioner appearing by NIKKI THOMPSON of Thompson, Guildner & Associates, Inc., P.S., and the Court having reviewed the files and records herein, finds that:

1. The Respondents named herein have been duly served with Petition and Summons.
2. State law enables the Court to dissolve the Snohomish Health District by Order.
3. RCW 53.48.030 governs the process for noticing the hearing date:

1 Order for hearing—Notice.

2 Upon the filing of such petition for an order of dissolution, the superior court  
3 shall enter an order setting the same for hearing at a date not less than thirty days  
4 from the date of filing, and the petitioner shall give notice of such hearing by  
5 publication in a newspaper of general circulation in the county in which the  
6 district is located once a week for three successive weeks, and by posting in three  
7 public places in the county in which the district is located at least twenty-one  
8 days before said hearing. At least one notice shall be posted in the district. The  
9 notices shall set forth the filing of the petition, its purpose and the date and place  
10 of the hearing thereon.

- 11 4. The Petition for Dissolution was filed on November 14, 2023; therefore the Hearing  
12 Date for the Entry of Order for Dissolution must occur after December 14, 2023.

13 **ORDER**

14 IT IS HEREBY ORDERED that the hearing date for the Entry of Order for Dissolution  
15 of the Snohomish Health District be set on Wed., Jan. 10, 2024,  
16 on Judge's Civil Motion Calendar at 9:30 a.m.
